Two dead (cause of death unknown/ both animals) Hereford/Angus mix heifer calves, both about 5 to 6 months old, owned by the complainant. One calf dead about 2 or 3 days. It was undamaged with the exception that the tip of its' right ear had been chewed off by scavaging animals. It was clear that the ear had been chewed. The other calf had been dead about 5 to 7 days. The right ear appeared to have possibly been cut off (the remainder of the ear was removed to be sent to CBI to try to determine whether or not the ear had indeed been cut off). A section of hide covering the right side of the dead animals head had been removed. Unknown whether it had been cut off or taken off by an animal; however, it looked as though it could have been cut from the animal. All the hide had been taken off from just below the right ear to the complete nose being gone, and from the center of the forehead around to the bottom of the left cheek or jaw bone. There was no portion of the tongue remaining in the animals carcass. The carcass was found by the complainant in a ditch that was about 2 feet deep, laying on its' stomach with both ears up. Only one ear, the right, was bothered. Photographs in B&W were taken. The animal was discovered by the complainant at about 10:00 AM this date, 10/20/75.



DETAILS: On Friday, September 12, 1975, the reporting agent was assigned to attend a meeting at the home of [REDACTED], [REDACTED], Colorado Springs, regarding the cattle mutilations. The reporting agent arrived at the [REDACTED] home at approximately 10:30 a.m.

Also attending the meeting were:

[REDACTED] telephone number [REDACTED], a rancher and officer of the Pikes Peak Cattlemen's Association.

[REDACTED], [REDACTED], telephone number [REDACTED], an officer of the Pikes Peak Cattlemen's Association.

[REDACTED], telephone number [REDACTED], the editor of Cattle Guard, the official magazine of the Colorado Cattlemen's Association.

[REDACTED] telephone number [REDACTED], a private investigator.

[REDACTED] stated that he had evidence that persons and vehicles from another planet were responsible for the series of cattle mutilations in Colorado. He stated that, with equipment specially built by him, he had successfully communicated with these beings. He had also interviewed persons who had been in personal contact with the beings and had been taken aboard their space ship. [REDACTED] stated that he believed the mutilations were a retaliatory action, taken after the United States Government had secretly captured a space ship in New Mexico and was holding it at the Los Alamos Research Laboratory. The captured beings were, by earth standards, three feet tall and weighed 75 pounds.

[REDACTED] played excerpts from a number of tape-recorded interview, which he claimed offered proof that UFO's had been sighted during a

number of the mutilations. These tapes had been edited, so it could not be determined if the sections played were taken out of context or contained valid descriptions indicating that conventional aircraft were involved.

██████████ stated that he wanted financial assistance as well as complete cooperation from local and state law enforcement authorities. He stated that he had contacted his congressional representative and the Department of Defense in hopes that they would order the cooperation but had been unsuccessful. Specifically, ██████████ demanded a meeting with Colorado Bureau of Investigation Director JOHN MacIVOR or his assistant at which time he would produce proof concerning the mutilations and outline his need for assistance. He further stated that if this meeting did not take place and, in view of the total lack of cooperation of the federal and local agencies, he would release all of his information to the news media and "blow the investigation sky high." ██████████ further stated that he has scheduled a number of meetings with various chapters of the Cattlemen's Association in hopes that he can pressure the CBI and local agencies to cooperate with him.

The reporting agent asked ██████████ to state his educational and scientific background. ██████████ stated that he has a Bachelor of Arts Degree in radio and television. For eight years he was employed in the Graphic Arts Department at the ██████████ but was forced to take a medical retirement due to a ██████████. He stated that he is a self-taught scientist and formed the Esthetic Science Company to bring out the truth about UFO's after the Government covered up the facts.

DETAILS: At 8:40 a.m., on April 15, 1976, the writer met with Investigator [REDACTED]

[REDACTED] telephone number [REDACTED] had arranged interviews with Sergeant [REDACTED] and Captain [REDACTED], both of the United State Air Force stationed in Colorado Springs. No previous notification was given to the subjects of the impending interviews.

At 8:54 a.m., the writer and Investigator [REDACTED] interviewed Technical Sergeant (E-6) [REDACTED], W/M - DOB [REDACTED] of [REDACTED] [REDACTED] telephone number [REDACTED] [REDACTED] stated that on March 13, 1976, about noon, he accompanied Captain [REDACTED] and a Negro air policeman identified as Sergeant [REDACTED] to the back room office of [REDACTED] Camera Shop. Also present were [REDACTED] (the owner), and a cowboy sculptor named [REDACTED] [REDACTED] They drank beer and talked, and [REDACTED] began telling about a time he went to [REDACTED] Bar with Captain [REDACTED] and a Lieutenant [REDACTED]. This incident took place in early November 1975. He apparently decided to "lay a story on the cowboy and the girl" and added the part about cattle parts and black magic. [REDACTED] and [REDACTED] have been friends for years, and they sometimes go into a routine where [REDACTED] accuses [REDACTED] of something, and [REDACTED] denies it and tries to get [REDACTED] to keep quiet. He stated that there was no truth to the part of the story about cattle parts and [REDACTED] being involved in black magic.

What actually took place at Wee G's was that [REDACTED] and his two companions went to the bar to drink, and [REDACTED] contacted an older female Negro who apparently managed the bar. [REDACTED] knew her because he gave her some liver on one previous visit when [REDACTED] was not presnet. [REDACTED] was also making loud remarks to the young female bartender, and [REDACTED] felt the remarks might be offensive to the girl and other male Negros in the bar. Since he and his friends were the only caucasians in the bar, he was a little concerned about his safety. [REDACTED] told him not to worry because he was in good with the manager.

[REDACTED] again assured the writer that [REDACTED] was not involved in cattle mutilations or black magic, and that the story was for the benefit of [REDACTED] and [REDACTED]. He also thought that he might have told the

story to make [REDACTED] a Negro, feel more at ease. He also advised that he and [REDACTED] have done many crazy things during their time together in the Air Force.

At 9:25 a.m., April 15, 1976, we interviewed Sergeant [REDACTED] N/M - DOB [REDACTED] of [REDACTED] telephone number [REDACTED] assigned to the [REDACTED] at [REDACTED]

[REDACTED] remembers being in the office of the camera shop with [REDACTED] [REDACTED], and [REDACTED]. [REDACTED] was telling a story about he and [REDACTED] going to some black club, and [REDACTED] was talking loud and making remarks to some woman. [REDACTED] said he became concerned about his personal safety, and [REDACTED] told him he knew the old woman who ran the place. She was dealing in black magic and [REDACTED] and gotten her some parts of a pig or cow and still owed her some more parts.

[REDACTED] went on to relate that [REDACTED] told him not to worry as nothing would happen to him as long as [REDACTED] still owed the woman some animal parts, and she had strong black magic. [REDACTED] then asked [REDACTED] if that wasn't true, and [REDACTED] replied he thought it was. [REDACTED] stated that he didn't know if the black magic and cattle parts story was true or not as [REDACTED] and [REDACTED] had been drinking before coming to the camera shop and after they had arrived there. [REDACTED] said he had heard [REDACTED] tell the story about [REDACTED] Bar twice before, and he had never mentioned the cattle parts or black magic until the day at the camera shop. It was [REDACTED] opinion that [REDACTED] and [REDACTED] added the cattle parts and black magic for [REDACTED] and [REDACTED] benefit. [REDACTED] asked [REDACTED] if he would like to get together and talk about black magic, and [REDACTED] said maybe sometime but never has.

At 9:50 a.m., April 15, 1976, the writer and Investigator [REDACTED] interviewed Captain [REDACTED], W/M - DOB [REDACTED] of [REDACTED] telephone number [REDACTED]. [REDACTED] stated that during the 1975 elk season, he went hunting with Sergeant [REDACTED], his son, [REDACTED] and a civilian Air Force employee from Buckley Airbase whose name he couldn't recall. They camped in the Shoe and Stocking Campground near Gore Pass. In the campground he met another hunter who was dressing out an elk he had shot. The unidentified hunter gave [REDACTED] the elk liver. When he and his companions returned home, [REDACTED] wife cut the liver in two pieces and kept half. [REDACTED] took his half home and put it in the refrigerator. A few days later [REDACTED] met a young Negro female in a bar. She asked [REDACTED] if he would give her a ride to [REDACTED] Bar so she could talk to the manager about a job.

[REDACTED] took the girl to the bar and met the old Negro woman who managed it. They talked a while and he asked her if she wanted some liver he had at home. [REDACTED] said he had had the liver unfrozen for so long


that he didn't want to eat it. The woman said she wanted the liver and so he stopped by the bar the next day and gave it to her. [REDACTED] admitted that after he took the girl to the bar to see the manager, he took the girl to a motel across the street from the [REDACTED] (where he works) and shacked up for the night.

He next visited [REDACTED] with [REDACTED], and he recalled that [REDACTED] became concerned about his safety because [REDACTED] was (according to [REDACTED]) talking too loud. He told [REDACTED] not to worry because he had given some liver to the manager. He may have told [REDACTED] that her black magic will take care of us. He may also have told [REDACTED] that he was going to get her an elk's tooth the next time he went hunting. He said he had been drinking a lot and didn't remember much of the conversation.

In regard to the camera shop conversation, he recalled being there with [REDACTED], and [REDACTED] and drinking beer in the camera shop office. [REDACTED] started telling the story about [REDACTED] and he recalls that he said something about [REDACTED] not having anything to fear from the blacks in the bar because he knew the manager, and she had black magic. He denied that he was ever involved in cattle mutilations or black magic.

Both [REDACTED] and [REDACTED] stated that they will come to the CBI in Denver at any time for a polygraph test.

The writer feels that [REDACTED] and [REDACTED] have no involvement in the cattle mutilations.

DETAILS: At 10:20 a.m., April 21, 1976, the writer received a call from Sheriff FLIETHMAN of Julesburg, Colorado advising that on April 20, 1976, two motorcycle riders found a cows tongue wrapped in a black cloth under a bridge near Julesburg. The sheriff further advised that the tongue had had heated pins stuck in it. There have been no reported cattle mutilations in Sedgwick County in 1976, but Sheriff FLIETHMAN wanted to call it to the attention of the CBI in the event there was any connection with the cattle mutilations. Agent TESCH was in the Julesburg area on April 21, 1976 and picked up the tongue from Sheriff FLIETHMAN for examination by the CBI Laboratory.

A laboratory examination determined that the tongue had numerous pins, which had been heated, stuck into it. The black cloth had what appeared to be the words "Juan Mata" printed crudely on it.

Agent STEPHEN OLIVAREZ advised that the tongue appeared to be a bruja or Mexican witchcraft symbol. The word "mata" means the head of a plant or in this case, the head of a family whose name is JUAN. The tongue is a threat delivered to the family because JUAN has been talking too much. The heated pins signify silencing JUAN's tongue slowly. If JUAN does not stop talking, the witchcraft will keep adding pressure on him until it causes his death.

The family who received the tongue probably threw it under the bridge to get rid of it.

Sheriff FLIETHMAN advised the reporting agent of the above information at 2 p.m., on April 27, 1976.

DETAILS: At the above date and time, the source called the reporting agent advising that he talked with a sculptor identified as [REDACTED], telephone number [REDACTED]. [REDACTED] told the source that he had recently been in [REDACTED] Camera Shop, Colorado Springs, operated by [REDACTED]. In the shop were [REDACTED] an Air Force non-com, and a commissioned officer identified only as [REDACTED]. [REDACTED] was talking about black magic and mentioned that he had delivered parts of cattle, eyes, tongues, etc. to a black woman at [REDACTED] Bar in Colorado Springs. [REDACTED] further stated that he had traveled as much as 300 miles to get these parts.

At 11:58 a.m., March 29, 1976, the writer interviewed [REDACTED] of [REDACTED] and [REDACTED] of [REDACTED] telephone number [REDACTED] at [REDACTED] Studio located at [REDACTED] no phone.

Mrs. [REDACTED] is the owner of [REDACTED] Camera Shop, [REDACTED] where the incident described above took place on March 13, 1976.

[REDACTED] and [REDACTED] stated on March 13, 1976 they were in the camera shop engaged in casual conversation with Sergeant [REDACTED] United States Air Force; Captain [REDACTED] United States Air Force; and an unidentified Negro male air policeman. [REDACTED] began telling about the time that he accompanied [REDACTED] to a Negro bar known as [REDACTED] on [REDACTED] Avenue in Colorado Springs. [REDACTED] is into black magic, and he and [REDACTED] had gone to the bar so that [REDACTED] could talk to an old Negro female. [REDACTED] stated that he was a little concerned for his safety, and [REDACTED] advised him that they were all right because he had black magic and he still owed some things to the Negro female. [REDACTED] explain that [REDACTED] procured animal parts (livers and eyeballs) for the black woman. He stated that [REDACTED] had traveled as far as 300 miles to get the animal parts. At the time of the conversation in the camera shop, [REDACTED] attempted to stop [REDACTED] from talking about the incident but he continued. [REDACTED] advised that

he has seen [REDACTED] and [REDACTED] since then, and they have avoided him. [REDACTED] stated that [REDACTED] and [REDACTED] both work at the [REDACTED] in Colorado Springs.

At 8:50 a.m., March 30, 1976, [REDACTED], [REDACTED], [REDACTED] telephone number [REDACTED] advised the writer that [REDACTED] and [REDACTED] both work at the [REDACTED] and will be made available for interview when requested. Neither of the two are pilots or has any contact with United States Air Force aircraft.

DETAILS: On September 16 and 17, 1975, the reporting agent contacted the following sheriff's departments in southeastern Colorado in reference to the animal mutilation investigations: Lincoln, Kiowa, Prowers, Bent, Otero, and Crowley counties. The reporting agent had previous contacts with Sheriff HUBBARD, Kit Carson County, and Sheriff RENNER, Cheyenne County, on September 15 at the Colorado Bureau of Investigation. Following is the information obtained from the contacts.

Lincoln County Sheriff's Department

Interview with MASON JONES, Undersheriff -- The latest mutilation reports were September 12, a cow with one ear, tongue, and skin around the lips excised and removed; September 11, a cow which was reported for insurance purposes, however, JONES examined the carcass and stated the mutilation bore no similarities to the other mutilations and will not be submitting a CBI mutilation report; September 11, a horse with one eyeball, tongue, one ear, and skin of half of the head excised and removed; and September 8, a cow with the skin from the stomach excised and removed. None of these carcasses had any maggots present. The CBI mutilation reports will be completed and forwarded in the near future.

Kiowa County Sheriff's Department

Interview with Sheriff LARRY WATTS -- WATTS related several strange occurrences in his county regarding the mutilations.

On September 8, 1975, [REDACTED], who lives within the city limits of Eads, discovered what appeared to be a large quantity of blood splashed on the steps of his back porch in the morning. It appeared that the liquid was dropped from some height above the residence as indicated from the pattern of the splash marks. It was estimated from the quantity discovered that at least a gallon of the liquid had been dispensed at this location.

On September 11, 1975, [REDACTED], also residing within the city limits of Eads, discovered the same liquid splashed on the rear porch steps of his residence in the morning. The same circumstances and estimated quantity existed as in [REDACTED] case. [REDACTED] advised that he had retired around midnight and heard nothing unusual through the night. [REDACTED] retrieved a quantity of liquid from the rear porch steps which he placed in a container. The sample was given to the reporting agent by WATTS for analysis by the CBI Laboratory.

On September 13, 1975, Sheriff WATTS accompanied his father to his father's farm located approximately 3 miles east and 3½ miles north of Eads. At the top of a hill, located on the property, and in the middle of a gravel road was an amount of what appeared to be splattered blood. It was estimated that approximately one gallon of the liquid had been spilled on the ground. No attempt was made to retrieve any of the liquid from this location.

WATTS also advised the reporting agent that at one of the cattle mutilations, several of the teeth had been pulled from the jaws. There was no indication that the teeth had been broken off or smashed out. WATTS stated that he could put his finger inside the cavities of the missing teeth, and none of the roots were present or broken off.

WATTS also stated that he and his undersheriff had discovered some unusual tracks at the scene of one cow mutilation. WATTS did not make a formal report regarding the discovery and advised the reporting agent that he had told only the Colorado State Patrol officers assigned to his district about the discovery, and that the reporting agent was only the second person he had told.

There were two types of tracks found at the scene. One was described as being similar to helicopter skid marks except for the dimensions. the skid marks were approximately four to five feet in length and approximately four feet apart. It appeared that whatever had caused the tracks had set down in four different locations around the carcass.

Also present at the scene were some other tracks, approximately five total. One at each of the four skid marks and one close to the carcass. They were described, in a rough sketch made by WATTS, as a bird-like foot impression. The length was approximately nine inches in length with a prominent round heel impression, and three distinct toes. The toes appeared to have a claw or toenail attached from the impressions found in the soil. No photographs were taken, and no attempts to make any castings of the tracks were made due to the dry, hard soil conditions which made the tracks faint.

WATTS then provided the reporting agent with two cow hooves from a previously reported mutilation. The hooves had been found approximately ten feet from the carcass. The hair attached to the hooves appeared to have been singed but not charred. WATTS requested that the hooves be examined by the CBI Laboratory.

Two CBI mutilation reports were given to the reporting agent, one reported on September 14 and the other on September 15. This brings to the total of eight mutilations reported in Kiowa County.

Prowers County Sheriff's Department

Interview with LARRY RICHARDSON, Undersheriff -- RICHARDSON stated that his department had not received any report from the Colorado State University Laboratory in reference to blood and organs from a mutilated cow sent to the laboratory for analysis on August 18. The victim's name was [REDACTED]

RICHARDSON stated that they were particularly interested in the results of this specific case because of a very strong, clinging odor unlike any other odor associated with dead animals and unidentifiable by either the sheriff's officers, the local veterinarian, Dr. SNIFF, or the owner of the dead animal.

RICHARDSON also stated that when they received the next report of a mutilation, his department was also going to call in an animal poisoning expert from La Junta as well as the local veterinarian.

Bent and Otero County Sheriff's Departments

Interviews with Sheriff EMRIE and Sheriff EBERLY -- Only one mutilation has been reported in Bent County. It was initially reported to Sheriff EBERLY in Otero County who investigated the mutilation. Photographs were taken, and a written report was made. A copy of the written report was given to the reporting agent.

Helicopter sightings have been rare in these two counties.

Crowley County Sheriff's Department

Interview with Sheriff DENTON -- The reporting agent was given two reports on recent mutilations along with reproductions of photographs taken at the scenes. Sheriff DENTON still feels that the cults are responsible. Helicopter sightings have been rare in this county.
