## REQUEST

Pursuant  
to the Idaho Public Records Act (Idaho Code § 74-101 et seq.), I respectfully request access to and copies of  
records held by the Idaho Attorney General's Office relating to a statewide investigation conducted by that  
office into reports of cattle mutilations  
during the summer and fall of 1975.

This  
request is based on contemporaneous reporting in The Times-News (Twin Falls, Idaho), October 2, 1977, in  
an article titled "Mutilation questions rise anew," which states that:

The  
Idaho Attorney General's Office initiated a statewide investigation into cattle mutilation reports in 1975;

Three  
legal investigators were assigned to the investigation;

Reports  
were gathered from approximately 22 Idaho counties;

The  
investigation was expected to conclude with a final statement or summary of findings;

The  
investigation subsequently concluded without the release of a public report.

## RECORDS REQUESTED

I  
request copies of all records generated, reviewed, or retained by the Idaho Attorney General's Office in  
connection with the initiation, conduct, evaluation, and conclusion of this investigation, including but not  
limited to:

Internal  
memoranda, summaries, briefing documents, or reports prepared for or by the Attorney General or staff;

Drafts  
of findings, conclusions, or proposed public statements, whether released or unpublished;

Correspondence  
(internal or external) discussing the scope, progress, conclusions, or termination of the investigation;

**Records**

explaining or documenting the decision not to release a final public report or statement;

**Administrative**

or legal closure documents indicating that the investigation had concluded or that no further action would be taken.

**For**

purposes of locating responsive records, this request includes records authored by, sent to, or referencing Neil (also spelled Neal) Custer, identified in contemporaneous reporting as a legal investigator or representative of the Idaho Attorney General's Office in connection with this investigation.

**This**

request does not seek individual ranch-level case files, veterinary reports, sheriff incident reports, or federal agency records, except insofar as such materials were summarized or referenced within Attorney General investigative records.
